Mr. Millet made some introductory remarks.

Mr. Millet thanked Alliance Safety Council Training Center and Joelle McGehee for providing our meeting space, along with VP Stephen Touns and Turner Industries for sponsoring lunch.

Mr. Millet announced upcoming meetings.

Mr. Cliff Barbier, CISSP, CISA, CISM, CRISC, spoke about the upcoming BSidesNOLA 2019 Information Security and Digital Forensics Conference, scheduled for Saturday, October 26th in the French Quarter.

Mr. Millet introduced Mr. Travis Broussard, Vice President of Business Development & Marketing, and Joelle McGehee of Alliance Safety Council, who spoke about the mission of the Alliance Safety Council.

Mr. Millet introduced SA Robert Thibault, the new InfraGard Coordinator, who made some introductory remarks, and spoke about critical threats to the US. His contact information will be posted on the InfraGard Louisiana website www.infragard-la.org.

Mr. Millet introduced our first speaker, Brandon J. Fremin, US Attorney for the Middle District of Louisiana. Mr. Fremin gave a talk about security threats to the US from China. He discussed priorities of the government of China to dominate the world's economy in 10 specific sectors, and the threat that this presents.

Mr. Millet introduced the second speaker, Mark Melancon, who spoke about "smart camera" technology as a deterrent to crime. He explained what "smart camera" systems are and how the systems are employed.

Finally, Mr. Millet introduced April Danos, InfraGard Board Member, and Col. (retired) Kenneth P. Donnelly of the Louisiana Cybersecurity Commission, who reported on the Ryuk Ransomware threat. April stressed the importance of two factor authentication. Col. Donnelly spoke about his role with the Louisiana Cybersecurity Commission.

Mr. Millet asked for agency and sector chief reports.

There being no further business to come before the meeting, it was adjourned on motion duly made and carried.
