Mr. Millet thanked the Lafayette Parish Sheriff's Department (Karen Matthews) for hosting the meeting and Global Data Systems (Tracey Webb) for sponsoring lunch.

Mr. Millet made announcements of upcoming meetings.

Mr. Millet presented SA Robert Thibault, InfraGard Coordinator, with an award recognizing his significant contributions towards the advancement of InfraGard Louisiana.

Mr. Millet introduced SA Natalie Phelan of the New Orleans Office as our first speaker.

SA Phelan gave a presentation entitled "Civilian Active Shooter Preparation and Response". Her presentation covered many aspects from a civilian response standpoint. SA Phelan discussed psychological aspects of typical shooters and presented information from recent events. She discussed the "Run, Hide, Fight" response to an active shooter.

SA Jerry Bezet with the FBI Counterintelligence Division gave a presentation about China and its trade policy. He discussed some details of the Chinese plan which include their debt and restrictions on access to their market for foreign products. SA Bezet discussed the requirements that are placed on foreign companies to access Chinese markets that compromise their intellectual property. He noted that intellectual property theft has been responsible for much of China's rapid rise as an economic power. SA Bezet discussed some of the strategies used to counter the threats posed by China's trade policy.

Mr. Millet asked if there was any old or new business.

There being no further business to come before the meeting, it was adjourned on motion duly made and carried.
