Mr. Millet called the meeting to order at 10:05 AM.

Mr. Millet introduced Tommy Waller, The Center for Security Policy, who is a Lieutenant Colonel in the Marine Corps Reserves and a combat veteran. Mr. Waller shared the story of a special flag he carried in combat. and asked Louisiana InfraGard Executive Director Lester Millet and Cdr. Eric Acosta to lead the audience in the Pledge of Allegiance with that special flag.

Cdr. Eric Acosta led the group in the Pledge of Allegiance, while Mr. Millet requested a moment of silence

Mr. Millet welcomed the Attendees and thanked The Lafayette Parish Sheriff's Office for hosting the May 05 Acadiana Meeting, along with Global Data Systems (Tracey Webb) for sponsoring Lunch, while encouraging non InfraGard Louisiana Attendees to apply for membership.

Mr. Waller introduced Brigadier General Robert Spalding, who previously served as Senior Director of Strategy at the National Security in the White House, as a defense attaché in Beijing, and as the commander of the nation's only B-2 Stealth Bomber unit.

General Spalding provided a thorough briefing on the threat by China to U.S. critical infrastructures, with a particular focus on the telecom industry.

Mr. Millet introduced Louisiana State Senator Barry Milligan, chairman of the Senate Select Committee on Homeland Security.

Senator Milligan discussed his work in the Louisiana Legislature to author and pass laws that will protect against foreign influence in academia and industry within the state, particularly with respect to the state's critical infrastructures.

Mr. Millet introduced the final speakers, SA Malcolm J. (Jerry) Bezet, FBI New Orleans, and SA Jesse Ginestar, FBI New Orleans, who presented on threats to 5G and Foreign Hybrid-Commercial Telecom Threats.

Mr. Millet reported on recent InfraGard Louisiana Partnered Events, Major Exercises, and Training, including the upcoming FBI N.O. / Tulane Crescent City THUNDER Exercise, scheduled for 16 June 2022 at the Le Méridien New Orleans Hotel, New Orleans,LA <u>https://silentthunder.sandia.gov/crescent-city-thunder</u>.
