Mr. Millet recognized Joshua Tannehill, who was recently elected by the InfraGard Louisiana Board of Directors as the new V.P. for the Acadiana Region.

Mr. Millet introduced acting ASAC Chris Soyez, FBI New Orleans, who discussed the importance of public /private partnerships, while thanking and praising CEO Millet and InfraGard Louisiana for their continued efforts.

Mr. Millet introduced the first guest speaker, SA Malcolm J. (Jerry) Bezet, FBI New Orleans, who presented on the ongoing China Threat posed to intellectual property, along with the Chinese Government's (PRC) continued intelligence efforts against the U.S.

Mr. Millet introduced the second guest speaker, acting ASAC Chris Soyez, FBI New Orleans, who provided a brief FBI N.O. Joint Terrorism Taskforce (JTTF) overview, along with a JTTF departmental breakdown. ASAC Soyez also discussed some current trending threats being tracked both nationally and in Louisiana (U).

Mr. Millet introduced the third speaker, Johnny Morse, who presented on the Sovereign Citizens Threat touching upon the following key topics: Who they are; What they believe; Threats They Pose; & Mitigative / Protective Measures.

Cdr. Eric Acosta, ILMA Sector Chief Coordinator, provided members an update on all InfraGard Louisiana Sectors.

SSA Corey Harris mentioned some current Cyber Security Threats trending in Louisiana, particularly Business Email Compromise (BEC), along with recommended protective measures (u).
