SAC Williams gave an outstanding and informative presentation on the current physical and cyber threats being seen in Louisiana, while touching upon the many different FBI Investigative Programs conducted at the FBI N.O. Field Office. As a final note, SAC Williams mentioned the current threats being faced by Law Enforcement.

Mr. Millet reported on recent InfraGard Louisiana related meetings and Exercises, while mentioning the following InfraGard La. Partnered events scheduled for 2023: Critical Infrastructure Protection & Resilience North America 2023 – Baton Rouge, LA 07-09 March 2023 & FBI 3rd Gulf Coast INLETS- New Orleans Marriott 26-30 June 2023.

Mr. Millet reported that the current InfraGard Louisiana financial balance is \$22071.94, as of 30 November 2022.

Mr. Millet introduced the second guest speaker, Buren "Ric" Moore, GOHSEP Intelligence Officer.

Mr. Moore delivered an excellent PowerPoint presentation on the GOHSEP 2022 CIKR (Critical Infrastructure / Key Resources) Risk Profile, touching upon the following key topics: Sixteen key DHS Sectors, Threat Scenarios, Risk Scores, Louisiana 2020 State Profile by region and risk rankings.

Phillip Constantin, DHS CISA PSA New Orleans, encouraged more aggressive suspicious activity reporting and mentioned some DHS CISA risk assessment tools, both physical and cyber, available at no cost to the user.
